#### How to Report Shelter or Housing Services (18D-1-18D-2)



- 18D-1. Emergency shelter or placement: Providing emergency short-term shelter to individuals and families following victimization. Reported per night (e.g., 1 person for 10 nights = 10 occurrences; 2 people for 10 nights = 20 occurrences)
- 18D-2. Transitional housing: Providing temporary housing for victims who, due to the nature of the victimization, cannot safely return to their former housing and need more time to stabilize themselves before living independently.

Reported per night (e.g., 30 nights = 30 occurrences)

### How to Report Shelter or Housing Services (18D-3)



- 18D-3. Relocation assistance: Coordinating assistance with initial rental expenses, utility deposits, security deposits, and/or moving fees. This includes assistance locating long-term housing for the victim, regardless of distance, based on safety needs.
   Reported per instance (e.g., 1 person receives 1 security deposit)
  - Reported per instance (e.g., 1 person receives 1 security deposit and 2 moving fees = 3 instances)

### How to Report Shelter or Housing Services (18D-4)



- 18D-4. Rapid rehousing
  - Starting in July 2025, rapid rehousing will be removed from the PMT and will not be an option for grantees.
  - Until then, we strongly recommend that this service category no longer be used. Instead, grantees should use the remaining housing categories to report services, as appropriate.

### How to Report Shelter or Housing Services (18D-5)



- 18D-5. Rental assistance: Providing assistance for a more permanent facility that is not a shelter, nor are its residents in transition. In other words, individuals anticipate living in the same place for a considerable length of time. This includes assistance with ongoing rental expenses, such as utility costs.
  - Reported per instance (e.g., 1 person receives 3 utility payments
    - = 3 instances, 2 people receive 3 months of rent = 6 instances)



### How to Report Shelter or Housing Services (18D-6–18D-7)



- 18D-6. Host homes: Transitional housing that facilitates the movement of individuals and families to permanent housing within a reasonable amount of time.
   Reported per night (e.g., 10 nights = 10 occurrences)
- 18D-7. Other Shelter/Housing: Any housing or housing-related services provided that are not covered in the previous categories. An explanation must be provided.
  - May be reported per night or per instance, depending on the service provided

#### Human Trafficking Grantee Performance Measures $\mathscr{S}$

OVC strives to uphold the intent of the Trafficking Victims Protection Act of 2000 and its subsequent reauthorizations to ensure that all trafficking victims—regardless of immigration status, gender, or form of trafficking—receive justice and support in accessing the services they need.

OVC manages the largest amount of funding across the Federal Government dedicated to providing services to victims of human trafficking. OVC strengthens the response to human trafficking through grant funding for victim services, multidisciplinary teams, statewide responses to child and youth trafficking, training and technical assistance, and leadership in the field.

In 2020, all performance measures across the OVC human trafficking portfolio were revised to -

- better reflect and report the activities of OVC's human trafficking grantees,
- standardize the questions across OVC's human trafficking portfolio, and
- align the human trafficking performance measures to OVC's other performance measures.

Data from the revised performance measures allow OVC to communicate to its stakeholders the full picture of the benefits realized with OVC grant funds. Where can I find my program's performance measures?
